NEW YORK TITLE ALERT

Westchester County Clerk Online

As you may be aware, effective January 1, 2010, the Westchester County Clerk will require on-line preparation of cover pages and tax forms for documents submitted to their office for recording in their web-based application, similar to New York City's ACRIS system. The site, https://prep.westchesterclerk.com/prep/webloginnew.aspx, is presently operational and documents may now be submitted using the PREP system. However, it is not mandatory until January 1, 2010.

All Tax Forms (RP-5217 forms and TP-584 forms) must be created on the new PREP system. When CB Title submits documents for recording in the Westchester Division of Land Records, we prepare the electronic cover page. When required for the document being submitted for recording, we can also on request prepare the Tax Forms in PREP for an applicable service charge. However, when Tax Forms are prepared in PREP by a party other than CB Title (the submitting Title Company), the Tax Forms must be "assigned" in PREP to CB Title in advance of closing to enable the cover page to be prepared. Without the Tax Forms being "assigned" in PREP, we will not be able to prepare the cover page and submit related instrument for recording.

If you are planning to use the PREP system, you will need to set up an account. Visit <u>prep.westchesterclerk.com</u> to create your account.
